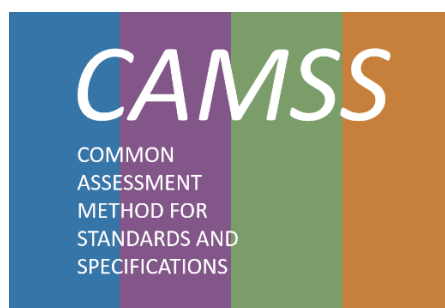

1.2. Release date

This version of the CAMSS Assessment of JPEG has been released on 16th of December 2020 in Joinup.

1.3. Description

CAMSS Assessment of JPEG v1.0.0 was released on the 16th of December 2020. This assessment has been performed following the scenario “EIF” using the CAMSS Tools. The purpose of this scenario is assessing the compliance of a standard or technical specification with the European Interoperability Framework (EIF)¹.
