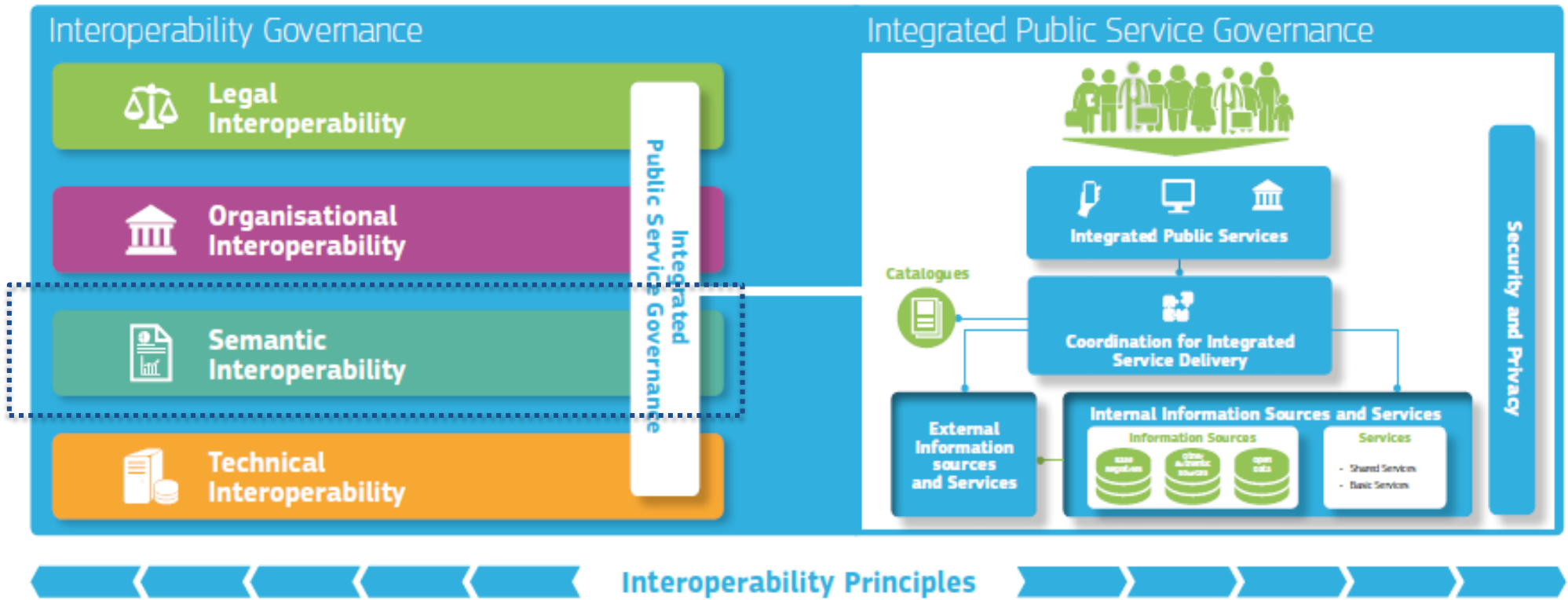


About the ISA² programme and SEMIC action

Objectives of the SEMIC action

- **Supporting alignments and agreements on common definitions and specifications** at the semantic layer for the Member States and the EU institutions.
