SUBJECT: ORACLE LICENSE COMPLIANCE AUDIT

MEETING: CABINET

DATE: 7th January 2015 DIVISION/WARDS AFFECTED: NONE

Immediately after the audit, SRS technicians made changes to the server environment and the Authority is now in compliance.

However in accordance to Oracle compliance policies the Authority is now liable to pay backdated technical support charges and compensation of $\underline{£2.13m}$ for the period of unlicensed usage of Oracle programs. Officers have taken legal and external advice and guidance, all of which confirms that a liability exists.

2. RECOMMENDATIONS:


2.1 That Cabinet agree to use the ICT reserve to cover compensation of $\underline{£202,420}$ for non-compliance with Oracle licensing terms and conditions.



Long tradition in shedding off existing vendor lock-in

- Main frame portfolio
 - Iso functional migration => 2 million euros
 - Re-engineering => cost X 10 to cost X 30
 - Strategy: long term and progressive phasing out of applications with changing business needs
- Application server: migration to open source (e.g. JBOSS) feasible;
- OS servers => Unix servers feasible;
- Databases => no good strategy yet for existing applications.

My car is my Castle

In order to increase competition in the aftermarket, the Commission ... adopted four commitment decisions binding Daimler, Toyota, General Motors and Fiat to provide technical information about car repairs to all independent garages in the EU. ... an obligation upon vehicle manufacturers to provide independent repairers with standardised access to all technical repair information



Regulation 1400/2002 aims at ensuring competition in the spare part market. ...does not allow ...to restrict the right of ... to obtain original spare parts and spare parts of matching quality ... Nor may vehicle manufacturers restrict the ... to sell original spare parts or spare parts of matching quality ... does not allow suppliers to restrict the right ... to sell spare parts to independent repairers ... for the repair and maintenance of motor vehicles.



What is possible for a 30,000 € car should also be possible for a 3,000,000 € software ...
