








 A new version of CoV is released based on three example regulations, a proposal for a regulation and a directive.

- Version 1 of CEM is adopted and released.
- The first prototype of an FMX2AK (Formex to Akoma Ntoso) converter based on CEM is implemented.
- An implementation road map drawn up under the 'to be' landscaping exercise is adopted.
- IMMCbuilder is available as a SaaS (software as a service') solution in the cloud
- The first exchanges based on CEM as part of the Commission/SG pilot project take place.
- Version 2 of CEM is adopted and released.
- The FMX2AK converter is extended and fully supports CEM version 2.
- eTrustEX and IMMC version 4 are implemented for all exchanges of legal data between the institutions and the OP
